2) Minutes of the meeting held on 13 June 2024

3) Matters Arising

4) Street Lighting to be fitted to Village Hall – no longer needed

5) Job Allocations

Jill to clean windows / sweep yard Malcolm/Richard to clean VH floor (Stephen to demonstrate how to operate floor cleaning machine) Richard to buy a yard brush, weed killer Stephen to buy hand wash / washing-up liquid Oil tanker monitor in VH - Graham to ask Michael Pickard

6) £15,000 Donation (in memory of Jonathan Gott)

Jonathan's widower has been asking if there had been any progress on the money being spent. Catherine and Kendal proposed a garden area with seating in the yard at side and front of VH. Richard to get someone to give a rough quote and pricing costs.

7) Water - Yorkshire water don't test for hardness or iron. Treatment normally done at borehole but residents don't join together.

Need pricing for unit to soften water and reduce iron and manganese. Had a quote from Springbore but awaiting Graham to get a quote from his supplier, Prosep. They will come to have a look when in area, coming soon.

8) Treasurer's report

Balance **£46,058.74** as of 31/10/2024 Graham reported Bank Accounts doing much better with a good return on money. Now getting a higher interest rate with Virgin. **Electricity** – **S**mart Meter still not working with Octopus. Trying to work on a solution - **ongoing**

9) Trust membership

10) Lease renewal

Gill Hall suggested it was best to leave the past alone and move forward.

The PCC will <u>not</u> sell the VH. It is now the only place for village events after losing The Club House. If there was nobody to run the VH the church would take over. There would be rent to pay as part of the new lease £150 per year, then the church would pay for the maintenance of the water borehole.

The lease expires March 31 2027.

Gill suggested a meeting with Lynne Cramman, Stephen and herself to discuss the way forward regarding the lease. Gill will organise the meeting. JH to write to Lynne Cramman (PCC) with a formal invite.
